Reservation Information

- Use of ball machine is by reservation only. To determine the availability and to reserve, please follow the instructions below:
 - Call the AC front desk- up to one week prior
 - Rentals are in 60 -minute increments
 - Only courts 1 or 2 are available for machine usage
 - Ball machines will not be available to use during peak USTA practice or match times.(Mon-Thur 6-8 pm and Sat 8-11 am)
- When checking in to use the ball machine:
 - Members will swap their car keys for the Club keys used to access the machine
 - Everything needed to utilize the machine is kept in the storage shed- outside of court one
 - Ball machine, balls and power cord
 - At the end of your reservation, please return all items back to the storage closet before retrieving your personal items at the desk.
 - Damage or loss to the remote will result in \$140 penalty.

Safety Information

- In case of inclement weather, promptly cease use and return equipment back to the storage area.
- Children under 18 must have an adult on court with them during use.
- Do not look into the barrel of the machine.
- Do not stand in front of the machine.
- Do not aim the machine at any person.
- Do not use the machine if it is wet or in standing water.
- Keep hands clear of the machine and do not place foreign objects on the ball machine.
- Keep power shift OFF when loading balls.

- Users of the ball machine assume all risk, responsibility and liability for injury or damage to person or property arising from use.
